According to the World Health Organization, over 5% of the world's population - or 466 million people - have a disabling hearing loss. Now imagine navigating the legal system, unable to hear. This workshop will be presented in two parts; part one will give an overview of the Deaf, DeafBlind, and Hard of Hearing Community, American Sign Language, and Deaf Culture, and part two will discuss how they navigate through the American Criminal Justice/Legal System and the various challenges and barriers they face.

#### Learning Objectives:

- Participants will discuss cultural and language differences between the Deaf Community and mainstream hearing community.
- Give examples of myths and truths about Deaf, DeafBlind, and Hard of Hearing Individuals
- Describe the role of a hearing interpreter, deaf interpreter, community health worker, and deaf victim advocate in various settings
- Practice signing basic signs, test lip reading skills, and experience relying on minimal hearing with loud background noise
- Discuss accommodations required by the Americans with Disabilities Act Practice using communication technology such as video phones and video interpreters.
- Identify language, cultural, and system barriers faced by deaf people in the criminal justice/legal system
